1. Welcome and apologies

2. Minutes of previous AGM (2019)

3. Chairman's Report (March 2019 to February 2020)

The highlight of the past year was undoubtedly the start of the new flying field properly nicknamed "Botfield" Ground clearance started on 26 March'19 and progress so far includes a levelled and rolled sub-base runway which is flyable but not ideal (way forward to be decided on) a starting area and poles planted for a pits area, shower and toilet. A new access road was also established. Costs will be dealt with under the financial report. Massive thanks to the sub-committee under leadership of Canz whom made this possible. A lot of committee meetings, hard work, sweat, swearing, own time etc. went into this venture. In addition, what other RC club has two flying fields to choose from?

We had a very successful fly in on Sat 27 Apr'19 and made a small profit for the first time in years due to a cut on expenses, club members and Micton Hobbies donating RC stuff for our boot sale on the day and members donating cool drinks, jaffels and wors for the boeries that was sold on the day. Thanks to all the members that contributed to the success of the day and the ones that came to join in the flying as well; this was a huge improvement on last year. We had 13 visiting pilots on the Sat

The club is in a sound financial state with no outstanding debts and a positive bank balance of R17 680.80 (financial report to follow)

Three (3) new members joined i.e. Russel Truter, Conrad Fick and Charles Smitheman (UK), 2 resigned and four were terminated due to non-payment leaving us with 78 current club members

Thanks to Canz for sponsoring weed and other poison, Nico Swart for sponsoring various items during club maintenance sessions and the grounds team of Theo and Stephen for keeping our club in shape

Thanks to Ron for keeping the website up to date, sponsoring data for our weather station and Dave for looking after the weather station

10. Club safety/ field maintenance

The chairman noted that we still have members flying over the non-fly zone and it is important to note the negotiations that have got us to where we are now where we can use the runway from Fisherhaven , the time allowed for 'noisy' engines and some days we have it 'open' for the whole day, including fly-ins. We have peg / card board to hang our membership card one when visiting the field and flying — please encourage all to use it.

11. Botfield discussion

The chairman opened the floor for discussions and the following points were raised as to how we got to the new field. By show of hands there was only one-member present at the meeting that indicated that he would not use the new field. The following comments arose from the floor.

- WBRF are not planning to close the Afdaks field.
- Both fields will be kept as long as practical
- Both fields are open to all members and no one is forced to fly at any particular field
- The intent of the new field was not only to cater for 'noisy' aircraft but also take a long term view that the Afdaks field could be sold at any time for development.
- The monthly rent negotiated with the farmer of R1500/monthly and includes space to store our trailer and mower. This is very reasonable considering what other clubs pay
- It was noted that that the Afdaks field took a long time and effort to reach the stage it is now

After a lengthy discussion with valuable input and comments, it was recommended that the new committee takes ownership as to how to progress the development of Botfield. Accepted by all.
